**NOTICE OF APPEAL AND STATEMENT OF FACTS
ALLEGING FURTHER VIOLATIONS OF THE
HUMAN RIGHTS OF KINI COSMA
ET AL BY THE UNITED STATES OF AMERICA**

Charges: Reckless Endangering

Unlawful tyrants have declared that a woman from a kosher Jewish conservative family is not entitled to legal protection or any other kind of relief. As a result of U.S. Government retaliation, she has had to take her cases to the International level that guarantees victims of human rights violations a right to a remedy for the violations they have suffered.

In the name of "terrorism" the U.S. Government refuses to improve the quality of life so that they can declare the standard whether a person is dangerous to him-or herself or others, or can't care for him- or herself to justify its oversight and injustices.

Constrained by circumstance, this author has been plunged into an abyss of misery. The prospect of being unable to live in a fully liberated manner has forced this author to slip into the isolated world of the heathen, the sloths and twits, the drunks and drug addicts, those with the banality of low mental acumen, police bullies and their punks, hooligans, and the perjuring lies of their informants while being forced to depend on and service the filth of American men.

Kini Cosma has been desecrated by America as a female stalker and sex offender and vilified as a human cunt eater. This has authorized disparate

treatments through a pattern of police brutality making Kini Cosma a mind controlled slave whose sense of reality has been turned upside down through prolonged and systematic torture.

This authors' fierce resistance and rigorous battles and appeals for violations of the internationally recognized prohibition of cruel, inhuman or degrading treatment or punishment, which governments are called upon to interpret so as to extend the widest possible protection against abuses, whether physical or mental, this author remains permanently driven from the work force and displaced in the U.S. citing the irreparable emotional scarring and the consequences of ostracism.

Robbed of all dignity, this author has had to endure prolonged sleep deprivation while the U.S. Government continues to inflict a constant stream of mental anguish through its agencies using disorientation, despair, hopelessness, and doubt.

While the cycle of violence against this author continues, so too does the malfeasance of the United States Government, their state and federal judges and police bullies. These attempts to destroy this author has become an obsession for the communities of Napa, California, Susanville, California, and Klamath Falls, Oregon.

Just recently, while more than four murders and a rape were taking place within eight weeks, more than 7 Klamath County Sheriffs, code enforcement officers, and dog control officers were congregated at my barn. Then, 7 Klamath County Sheriffs, code enforcement officers, and dog control officers immediately

thereafter congregated at my home ready to arrest me for "Reckless Endangering" as a result of a superficial dog bite a man sustained. Judges Richard Rambo and Roxanne Osborn are responsible for this injury and they must be held accountable.

Kini filed for a restraining order from punks and hooligans who were menacing her, her wild horses, and dog. All actions were dismissed. Yet, a restraining order was placed on Kini for a superficial dog bite a man sustained at the Senior Citizens Center when she found it necessary to stop briefly to use the restroom.

This is like the movie "Changeling" where the police were so busy trying to commit a mother to a mental institution they failed to prevent or thwart the Chicken Coop murders of countless boys.

Circuit Court Judge Richard Rambo of Klamath County was placed on notice that Kini Cosma was tortured by the U.S. Government through a housing contract. Recklessly, he succeeded to advance further damage. As a result, Kini Cosma was evicted in four days and was forced to weather the freezing elements during the winter months of 2008 in Oregon while losing over \$15,000 of business equipment.

Years of these hostile techniques are being used as a direct effort to alter the content and form of this author's thoughts. Now, Kini Cosma may no longer seek refuge at the Seniors Citizens Center in Klamath Falls, Oregon. Kini may no longer use the public telephone, participate in energy assistance, use the public restroom, watch TV or associate with such persons.

To date, Kini Cosma remains unlawfully detained until her "trial" on January 27, 2010 for the shenanigans of Judges Richard Rambo and Roxanne Osborn. Accordingly, Judge Richard Rambo of the Klamath County Circuit Court has decided to **violate this author's right to a speedy trial.**

HOW LONG WILL THE TORTURE CONTINUE?

For over 15 years, Kini Cosma has been wrongly scapegoated and criminalized because she is a lesbian. These actions are being permitted to forcibly change her very ability to formulate particular thoughts and are contributing to the hateful expressions to tally its score in the forms of making ALL LEGAL ACTIVITIES ILLEGAL.

While civil and criminal cases against this author are being passed through the "revolving doors of 'justice'," discrimination and bias continues to rule on the basis of this targeted Individual's identity, including her gender, ethnicity, sexual orientation, gender identity, expression and disability so that Kini will remain to be made odd in society.

Since these factors have singled her out as an individual for abuse, access to remedies have hindered her with the heighten risk of retaliatory action and have advanced to gang mind stalking to promote hatred and hostility.

Despite, having three resumes with vigorous completions, Kini Cosma has been prohibited from becoming gainfully employed. Her driver's license was illegally seized allowing police bullies to confiscate her, inter alia, residential van while leaving her in the winter freeze.

As these effective "anti-terrorism" practices continue in force, the U.S.

Government continues to choke and suffocate the life out of this author with their barrage of false hope and hopelessness intended to induce forced-drugging for cognitive decline.

Seemingly, the U.S. Government affirms, "These attacks are for her best interest to 'protect society' and so that the destruction of her personality immobilizes her to become a sitting duck that can be experimented upon!"

Massive gross human right violations of abuse have been reported conversely making this author's mind work in a manner nature could never have designed for survival's sake.

Standing helpless in the presence of such unspeakable pain is not easy and survival for one who has been destroyed of personality and diminished of physical strength is hard. For instance, the next door neighbor who has nothing better to do than wait for this author to do something to which he makes a programmed response.

He/she waits for Kini Cosma to go left or right, go to sleep, wake up, go to the bathroom or shower, just so they can hiss, murmur, whisper, conduct intimidation by police bully surveillance or to make sounds of blaring sirens or engage in such activity, by so doing attempts to make it plain that all gays are sinful and promiscuous and that the so-called "homosexual lifestyle" can be "cured" by oppressive tactics.

Targeted for marginalization, these compromises of human integrity have pressured people to treat this author badly, which are actions contrary to basic humanity. It has prevented people from appreciating all forms of diversity in

society. For all of these negative attitudes that linger in society, the homophobia that traumatizes countless hate crime victims are still being perpetrated.

A government that is permitted to manipulate a citizen's consciousness at its very roots—by years of constant alienation can force a victim of U.S. torture to take mind-altering drugs—Then, the U.S. Government need not censor speech, because it could prevent the ideas from ever occurring in the mind of the speaker.

Discriminated from all public services others are entitled to, harassment continues to exclude her from participating in constitutionally protected activities, exercise instructions at sports and health centers, seminars, events, or even to participate in medical health care.

This authors' overall health was already impaired while at a higher risk for a heart attack; Years of aggravated and provoked pain to her preexisting scoliosis condition, crippled with scorn, false accusations and malicious prosecutions, taunted and offended verbally, physical assaults, being torn apart and fiercely threatened; The pain has sapped strength, consciousness and poise, and has contributed to muscles feeling faint from disuse among a pack of fucking sissies and paranoiacs who will say anything to get laid or to extort money for their drug and alcohol habits.

The incurable wound for not being able to protect her children from corrupt U.S. officials have been unbearable. Nausea, changes in blood pressure, heart and respiratory rates, nystagmus (darting of the eyes), slurred speech, hand tremors, increased pain sensitivity and hyperactive reflexes, body temperature

regulation, mind-mood changes including irritability, sadness, lack of motivation, poor concentration and a reduction in short-term memory are draining the life from this 52 year old woman in order to justify the malicious prosecutions by the U.S. Government.

The fundamental right to control one's own intellect and mental processes is eviscerated if courts permit the government to forcibly drug citizens when a torture victim has been cornered with no where to go.

If state officials, with the concurrence of the courts, can constitutionally order the forcible alteration of this authors' mind in order that she must stand trial while being maliciously prosecuted, then every other accused defendant, who poses no danger to himself or others, is also at jeopardy of losing his or her right to freedom of thought.

Essential to the most elementary concepts of human freedom, dignity, and self-determination, a person has a fundamental right to cognitive liberty – a right to freedom of thought, to independent thinking, to autonomy over his or her own mind and brain chemistry, and the right to experience the full spectrum of possible thought and consciousness.

By altering a person's mind with the forced administration of drugs, the government commits an act of cognitive censorship and mental manipulation, an action even more offensive to democratic principles than the censorship of speech. Chemical manipulation of the mind is the ultimate prior restraint on speech.

Because this authors' demeanor can be considered by the "jury," the

government's manipulation of this author's demeanor raises the same concerns as if the government had manipulated material evidence.

The right to self-determination over one's own intellect and mental processes is more than significant. It is situated at the very core of what it means to be a free person in a civilized society and is a fundamental right of the highest order.

For over 15 years, Kini Cosma continues to witness others, who are unduly deserving of police services, retain competent counsel for representation, validated driver's license, returned custody of their children, employment, etc. while Kini is used as a human battering instrument for all to defile without restraint.

Complainant(s) have received assistance to bring their offenders to "justice" for wrongful conduct. Yet, this author has been steadily ignored and perceived as pestiferous.

Her rightfully inherited trust funds of \$100k were illegally seized by Alco Metals. Despite numerous complaints by Kini, still no actions have been taken or her trust funds returned to its rightful owner.

Before this present case of "Reckless Endangering," on March 12, 2009, this author filed a complaint for judicial misconduct adopted by the Judicial Conference of the United States at the Oregon U.S. District Court, Mark O. Hatfield U.S. Courthouse, 1000 S.W. Third Avenue in Portland, Oregon 97204-2902. No acknowledgment was ever received in regard to any pending investigations. (Attached hereto)

For all of these reasons, this author accuses this judge, Richard Rambo of manipulating material evidence by, inter alia, his violations of Kini's right to a speedy trial.

Judge Roxanne Osborn did not consider the merits or evidence of this author's restraining order against hooligans who were menacing Kini and her animals. Instead, she referred Kini Cosma to "mental health" to do Osborn's job. As a result, she was responsible for the superficial dog bite an alleged victim suffered.

Convincingly, as the months proceed until Kini's trial, Osborn has received implicit honor for her work in the community through public exposure in the local newspaper. Conclusively, for all of these reasons, this author accuses Judge Roxanne Osborn for hindering this author's right to a fair and impartial trial.

I, Kini Cosma, hereby declare under penalty of perjury the foregoing is true and correct to the best of my knowledge.
